- 4. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the date of the Sanction Order. As per the conditions contained in Para 15.4 of the guideline of Multi Sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and work plan for the requisitioned amount may also be furnished.
- 5. The UT Administration of A & N Island should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.
- 6. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.
- 7. This is to certify that the present sanction/ecpenditure is covered under MEP for the month of Feb 2018 and Integrated Finance Division (IFD) has approved the expenditure during the fourth quarter of the financial year 2017-18.
