IMPORTANT INSTRUCTIONS

- The details of the scheme including eligibility criteria for coaching institutions, stipend payable to candidates/students, fee payable to the coaching institutes for various coaching programmes and application format etc. can be seen and downloaded from "What's New" on the website of the Ministry of Minority Affairs i.e. http://minorityaffairs.gov.in.
- The proposals should be sent online as well as by post. As the online Portal for Free Coaching and Allied Scheme of MoMA is under construction, eligible institutions/organisations may send Hard Copy of the proposal and the same may also be sent through the online Portal once it becomes operational. The details of the portal will be intimated later.
- The organizations should be registered on NITI Aayog NGO Darpan Portal.
- The coaching institutes/organizations in the private sector will submit their complete proposals in the prescribed application form (Part I & II) along with the all necessary documents. The proposals should be forwarded by the State Government / District

- Authority/District Minority Welfare Officer* along with inspection report in Part III and recommendation in Part IV to Under Secretary (FC), R. NO. 1130, 11th Floor, Pt. Deen Dayal Antyodaya Bhawan, CGO Complex, Lodhi Road, New Delhi-110003.
- Institutes in Government Sector/Public sector Undertaking may submit their proposals directly to the Ministry at the above address.
- If an organisation applies for more than one state/district, separate recommendation of respective State Government/District Authority would be mandatory.
- Application form should be completely filled and duly signed by President/Secretary/CEO/Head of Institution/Registrar of the organization.
- Ministry of Minority Affairs reserves the right, without any

 proposals at any stage of the process, to cancel or modify
 the process or any part thereof, or to vary any of the terms
 and conditions at any time, without assigning any reasons
