Sir,

In continuation to this Ministry's sanction letter of even number dated 03.12.2019, I am directed to convey the sanction of the President for release of Rs. **15,55,20,000/- (Rupees Fifteen Crore Fifty Five Lakh Twenty Thousand Only)** as 2<sup>nd</sup> installment to Aligarh Muslim University for construction of projects under the scheme "Pradhan Mantri Jan Vikas Karyakram (PMJVK)" within the University premises which lies in identified Minority Concentration Areas (MCAs) of the State of West Bengal. Details of the projects are given in **Annexure-I**.

2. Utilization Certificate for this grant should be submitted by the Aligarh Muslim University in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 12.5 of the guideline of PMJVK (i) Quarterly Progress Report (ii) Utilization Certificate along with EAT report (downloaded from PFMS portal) of their expenditure of grants received from ministry duly signed by the Head of the institution, (iii) Report regarding release of the State share in case of innovative projects and (iv) Photographs of the Asset so far created will also be furnished.

3. All payment to the vendors shall be made only through the EAT module of the PFMS. Funds should be released by the Aligarh Muslim University to the implementing agencies immediately upon receipt of the same from Govt. of India. As per the directions Govt. of India, Ministry of Finance, parking of funds at any level is strictly prohibited

4. Utilization of the above mentioned amount by the State Government is subject to the terms and conditioned at Annexure-II.

5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be/has been selected for the projects mentioned at Annexure-I and also that duplication will not take place.

6. The Central University should ensure that a board containing information as per the template enclosed at **Annexure-III** is displayed at the project site. After completion of the projects, a permanent display board should be installed.
