Subject: Grant in aid for engagement of Block Level Facilitators (BLFs) under the Centrally Sponsored Scheme of Pradhan Mantri Jan Vikas Karyakram for Minority Concentration Areas (MCAs) to the State of Arunachal Pradesh for 2020-21 during 2021-22.

Sir,

In continuation to this Ministry's sanction letter of even number dated 24.09.2020, I am directed to convey the sanction of the President for release of total amount of **Rs.36,11,000 /- (Rupees Thirty-Six Lakh Eleven Thousand Only)** to the Govt. of Arunachal Pradesh for engagement of Block Level Facilitators (BLFs) as per details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of Arunachal Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The expenditure is debitable to Demand No. 69, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 - General- (Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 64- Pradhan Mantri Jan Vikas Karyakram for minorities, 64.00.31 Grant in Aid General for the year 2021-22.

3. Utilization Certificate for this grant should be submitted by the State in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 12.5 of the guidelines for Pradhan Mantri Jan Vikas Karyakram.

4. A list of the engaged BLFs should be submitted to the Ministry along with their qualification, date of joining, contact number and the name of block where they have been deployed.

6. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at Annexure-II.

7. The amount of Rs. 36.11 lakhs has been re-appropriated from Major Head 2552.00.449.24.00.31 to Major Head 3601.06.101.64.00.31 vide re-appropriation order no 18/2021-2022(NER) dated 15.09.2021, 2021 of Budget Division, Ministry of Minority Affairs.


