Subject: Grant-in-aid for engagement of Block Level Facilitators (BLFs under the Pradhan Mantri Jan Vikas Karyakram (erstwhile Multi-sectoral Development Programme), Centrally Sponsored Scheme for Minority Concentrations Areas in the State of Assam.

Sir,

I am directed to convey the sanction of the President for release of an amount of Rs. 2,49,60,000/- (Rupees Two Crore Forty Nine Lakh and Sixty Thousand Only) to the State Government of Assam towards remuneration of Block Level Facilitators (BLFs) as per details given at **Annexure-I**.


