Sir,

In continuation to this Ministry's sanction letter number 3/5(2)/2013-PP-I dated 29.03.2017. I am directed to convey the sanction of the President for release of Rs. **85,20,000/- (Rupees Eighty Five Lakh Twenty Thousands only)** as 2<sup>nd</sup> instalment to the Govt. of Bihar for implementing the scheme "Pradhan Mantri Jan Vikas Karyakaram" (erstwhile MsDP) in Minority Concentration Areas of Kishanganj District for the year 2019-20 as per the details at **Annexure - I**. 3. The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 64-Pradhan Mantri Jan Vikas Karyakram for minorities, 64.00.35 Grant for creation of capital assets the year 2019-20.

4. **The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be/has been selected for the projects mentioned at Annexure-I and also that duplication will not take place.**

5. A copy of the Utilization certificate of 1<sup>st</sup> installment is enclosed. Further it is certified that no UC is pending for this project.

6. Utilization of the above mentioned amount by the State Government is subject to the terms and conditioned at **annexure-II**.




