Subject: Grant in aid under the Centrally Sponsored Scheme of **Pradhan Matri Jan Vikas Karyakram** for Govt. of Kerala .

Sir,

I am directed to convey the sanction of the President for release of an amount of **Rs. 5,25,16,000/- (Rs Five Crore Twenty Five Lakh Sixteen Thousand only)** as 1st installment for the year 2019-20 to the Govt. of Kerala for implementing the scheme "**Pradhan Matri Jan Vikas Karyakram (PMJVK)**" in Minority Concentration Areas (MCAs) of the State of Kerala as per the details enclosed at **Annexure I**. The non-recurring grant may be released to the Govt. of Kerala through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of 50% of State share for the projects mentioned at Annexure-I is released to the implementing agency alongwith Central share.
3. The expenditure is debitable to Demand No. 68, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101- General- (Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) - other grants (Minor Head), 64 - Multi sectoral Development Programme for minorities, 64.00.35 Grant for creation of Capital Assets for the year 2019-20.
4. Since it is a fresh release for the plan of PMJVK, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 12.5 of the guideline of PMJVK, (i) Quarterly Progress Report, (ii) Utilization Certificate, (iii) Report regarding release of the state share and (iv) Photographs of the Assets so far created should also be furnished.
5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at **Annexure-I** and also that duplication will not take place.

7. This is to certify that the present sanction/expenditure is covered under MEP for the month of Sept 2019 and Integrated Finance Division (IFD) has approved the expenditure during the 2nd quarter of the financial year 2019-20.

8. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

9. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at **Annexure-II**.

10. This sanction issues with concurrence of IFD vide their Note. No. 10 on file no. 13/56/2019-MsDP-MOMA dated 16.09.2019. It is noted at S. No 42 in the Grant-in-aid Register.

- iii. The grantee will ensure that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
- iv. Grantee shall not divert any part of the grant to any other activities.
- v. Grantee shall be governed by all the terms and conditions of the grant as prescribed in the scheme/programme and in GFR.
- vi. Grantee shall endeavor to achieve the quantified and qualitative targets.
- vii. Grantee will ensure that there is no duplication of work.
- viii. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
