Subject: Grant in aid for conducting baseline survey under the Centrally Sponsored Scheme of Multi-sectoral Development Programme for Minority Concentration Blocks to Government of **Tripura**.

Sir,

I am directed to convey the sanction of the President for release of an amount of Rs. 11,60,000/- (**Rupees Eleven Lakh Sixty Thousand only**) to the Govt. of Tripura for conducting baseline survey each in 12 Minority Concentration Blocks of 4 districts of the State of Tripura (@ Rs. 1 lakh per MCB for 10 MCBs of 3 districts and Rs. 0.80 lakh per MCB for 2 MCBs of South Tripura district) in terms of guidelines of Restructured MsDP and letter no. 3/32/2012-PP-I(pt) dated 19.8.2013 of this Ministry. The list of MCBs is enclosed at Annexure-I.

2. The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 02- Grants for State Plan Scheme (Sub Major Head), 378 -General-(Welfare of Schedule Casts, Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 01 - Multi-sectoral Development Programme for minorities, 01.00.31 - Grant-in-aid general for the year 2014-15.

3. Since it is fresh release, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the date of the Sanction Order.

4. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditions at Annexure-II.

5. A copy of report should be sent to the Ministry immediately after the completion of the survey.

- vii. Grantee will ensure that there is no duplication of work.
- viii. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
