Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Blocks (MCBs) to Government of **West Bengal for the year 2014-15 for Nadia District.**

Sir,

In continuation to this Ministry's sanction letters of even number dated 19.08.13, 29.03.14 and 16.06.14. I am directed to convey the sanction of the President for release of an amount of Rs.20, 95, 41, 750/- (**Rupees Twenty crore Ninety Five lakh Forty One Thousand Seven Hundred Fifty only**) as 2nd instalment to the Govt. of West Bengal for implementing the scheme "Multi Sectoral Development Programme for Minority Concentration Blocks (MCBs) in Nadia district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of West Bengal CAS, Reserve Bank of India, Nagpur.

The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Governments, 02- Grants for State Plan Schemes (Sub Major Head), 378 -General- (Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes and Minorities) -Other Grants (Minor Head), 01 - Multi sectoral Development Programme for minorities, 01.00.35 - Grant for creation of capital assets for the year 2014-15.

4. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.

8. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at annexure-II.
