Subject: Grant in aid for engagement of Block Level Facilitators(BLFs) under the Centrally Sponsored Scheme of Multi-sectoral Development Programme for Minority Concentration Blocks to Government of **West Bengal**.

Sir,

In continuation to this Ministry's sanction letter of even number dated 21.07.2014, I am directed to convey the sanction of the President for release of an amount of Rs. **1,69,20,000/- (Rupees One crore sixty nine lakh twenty thousand only)** to the Govt. of West Bengal for engagement of Block Level Facilitators(BLFs) each in 94 MCBs of the State of West Bengal. The sanction amount includes monthly remuneration of BLF (@Rs. 10,000 per month) and expenses towards TA/DA (@Rs. 5000/- per month) for 12 months from the date of joining of BLFs, in per terms of Para 14 of the guideline on restructured MsDP and letter no. 3/31/2012-PP dated 19.8.2013 of this Ministry.

2. The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 02- Grants for State Plan Scheme (Sub Major Head), 378 -General-( Welfare of Schedule Casts, Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 01 – Multi-sectoral Development Programme for minorities, 01.00.31 - Grant-in-aid general for the year 2014-15.

3. Since it is fresh release, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the date of the Sanction Order.

4. A list of the BLFs should be submitted to the Ministry along with their qualification, date of joining, contact number and the name of block where they have been deputed.
