Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for block to Government of **Manipur for the year 2016-17 for Imphal East District.**

Sir,

In continuation of this Ministry's sanction number of even number dated 30.12.2015, I am directed to convey the sanction of the President for release of an amount of **Rs. 5, 04,52,200** /- (Rs Five Crore Four lakh Fifty Two Thousand Two Hundred only ) as 2<sup>nd</sup> installment for the year 2016-17 to the Govt. of Manipur for implementing the scheme "Multi Sectoral Development Programme for Imphal East CD Block (Minority Concentration Block) in Imphal East district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of Manipur through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of State share for the projects mentioned at annexure-I is released to the implementing agency alongwith Central share.
3. The expenditure is debitable to Demand No.60, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Governments, 02- Grants for State Plan Schemes (Sub Major Head), 378 -General- (Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes and Minorities) -Other Grants (Minor Head), 01 - Multi sectoral Development Programme for minorities, 01.00.35 – Grant for creation of capital assets for the year 2016-17.
4. A copy of the Utilization certificate of 1<sup>st</sup> instalment is enclosed.
5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.
6. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 8.4 of the guideline of Restructured Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Utilization Certificates and (iii) Report regarding release of the State share in case of innovative projects may also be furnished.
7. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.
