- 4. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 8.4 of the guideline of Restructured Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Utilization Certificates and (iii) Report regarding release of the State share in case of innovative projects may also be furnished.
- 5. A list of the engaged BLFs should be submitted to the Ministry along with their qualification date of joining, contact number and the name of block where they have been deputed. Utilization of the above mentioned amount by the State Govt. is subject to the terms and condition at Annexure-II
