**Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Districts (MCDs) to Government of Arunachal Pradesh for the year 2012-13 for West Kameng District.**

Sir,

In continuation to this Ministry's sanction letter of even number dated 14.12.2010, 30.03.11, and 19.08.11, I am directed to convey the sanction of the President for release of an amount of Rs. **5,93,65,000/- (Rupees five crore ninety three lakh and sixty five thousand only)** as 2<sup>nd</sup> instalment (50% of total central share) of the total sanctioned amount of Rs. **11,87,30,000 /- (Rupees eleven crore and eighty seven lakh and sixty five thousand only)** for the year 2012-13 to the Govt. of AP for implementing the scheme "Multi Sectoral Development Programme for minority concentration district districts" for West Kameng district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of AP through CAS, Reserve Bank of India, Nagpur.

2. The State Government is advised to ensure that proportionate share of 50% of state share (i.e. ₹ 43.55 lakhs) for different projects is released to the implementing agency alongwith Central share of ₹ 593.65 lakh.
3. The expenditure is debitable to Demand No.67, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Centrally Sponsored Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts, Schedule Tribes, Other Backward Classes and Minorities) - Other Grants (Minority Head), 04 - Multi sectoral Development Programme for minorities in selected minority concentration districts, 04.00.35 - Grant for creation of capital assets for the year 2012-13.
4. A copy of the Utilization certificate of 1<sup>st</sup> instalment is enclosed. Further it is certified that no UC is pending for this programme.
5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.
6. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount with milestones and time frame may also be furnished.

After completion of projects, a permanent display would be installed.


8. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

9. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.

10. This sanction issues with concurrence of IFD vide their Dy. No. 34/IFD dated 09.05.2012. It is noted at S. No. 04 in the Grant-in-aid Register.



- viii. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
