Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for minorities to Government of **Uttar Pradesh for the year 2012-13 for Muzaffar nagar District.**

Sir,

In continuation to this Ministry's sanction letter of even number dated 31.12.08, 16.02.10, 08.01.10, 19.03.10 and 16.12.10, for the release of 1st instalment, I am directed to convey the sanction of the President for release of an amount of Rs. **6,21,84,000/- (Rupees six crore twenty one lakh and eighty four thousand only)** comprising of following:-

- (i) Rs.615.00 lakh as 1st instalment 50% of total central share of approved amount Rs. 1230.00 lakh
- (ii) Rs. 6.84 lakh as 2nd instalment for the construction of toilets in primary and upper primary schools

as per the details enclosed at Annexure-I for the year 2012-13 to the Govt. of Uttar Pradesh for implementing the scheme "Multi Sectoral Development Programme for minority concentration district" for Muzaffar nagar district. The non-recurring grant may be released to the Govt. of Uttar Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The expenditure is debitable to Demand No.67, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Centrally Sponsored Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts, Schedule Tribes, Other Backward Classes and Minorities) -Other Grants (Minority Head), 04 - Multi sectoral Development Programme for minorities in selected minority concentration districts, 04.00.35 - Grant for creation of capital assets for the year 2012-13.

3. The Polytechnic is to be constructed as per the estimates prepared as per Schedule of Rates of the State Government approved by a competent engineering department.

4. A copy of the Utilization certificate of 1st instalment is enclosed. Further it is certified that no UC is pending for this programme.

5. Since, the amount of Rs. 615.00 lakh is a 1st instalment, no previous UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii)

6. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.

7. The amount would be scrupulously deducted if any deviation, is found at any stage of the implementation of the scheme.

8. Funds should be released by the State Govt. to the implementing agencies only after all the conditions stipulated while approving the projects are fulfilled. As per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited Ministry of Finance; parking of funds at any level is strictly prohibited.

9. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditions enclosed at annexure-II.
