
I am directed to convey the sanction of the President for release of an amount of Rs. **15,55,44,000/- (Rupees fifteen crore fifty five lakh forty four thousand only)** as 1st instalment (50% of total central share) of the total sanctioned amount of Rs. **31,10,88,000/- (Rupees thirty one crore ten lakh eighty eight thousand only)** for the year 2009-10 to the Govt. of Assam for implementing the scheme "Multi Sectoral Development Programme for minorities" for Dhubri district as per the details enclosed at Annexure. The non-recurring grant may be released to the Govt. of Assam through CAS, Reserve Bank of India, Nagpur.

2. The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head-"3601" Grant-in-aid to State Government, 04- Grants for Central Plan Scheme (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) -other grants, 04 - Multi sectoral Development Programme for minorities, 04.00.31 - Grant-in-aid for the year 2009-10.

3. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the date of the Sanction Order.



After completion of projects, a permanent display would be installed.



Indira Awas Yojana (IAY):

- (i) State Government would ensure that the IAY houses would be constructed in villages with the highest minority concentration, BPL families would be selected from the approved waiting list, even if they belonged to communities other than the minority communities, strictly in order of their ranking in the list as per the IAY guidelines.
- (ii) It was stressed that no deviation from the guidelines was permitted.
- (iii) The list of the villages, indicating the number of houses to be constructed would be provided. State share would be provided.
- (iv) To prevent duplication, the Government of Assam would ensure that the IAY units funded under MsDP were reflected in the State Action Plan of the scheme and information also sent to the Ministry concerned.
