Subject: Grant in aid for setting up of an IT Enabled Dedicated Cell in 12 MCDs under the Centrally Sponsored Scheme of Multi sectoral Development Programme for minorities to Government of West Bengal for the year 2009-10.

3. Since it is fresh release, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the date of the Sanction Order.

4. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.


