- The State Government should ensure that a board containing information of the date of sanction of 4. the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.
- Funds should be released by the State Govt. to the implementing agencies immediately upon 5. receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.
- Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.
- This sanction issues with concurrence of IFD vide their Dy. No. 847/IFD dated 29.12.10 It is noted at S. No. 102 in the Grant-in-aid Register.
