Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for minorities to Government of **Uttar Pradesh for the year 2010-11 for Budaun District.**

Sir,

In continuation to this Ministry's sanction letter of even number dated 06.07.09 and 11.03.10, I am directed to convey the sanction of the President for release of an amount of Rs. **1,72,50,000/- (Rupees one crore seventy two lakh and fifty thousand only)** as 1<sup>st</sup> instalment for the construction of Polytechnic with two hostels after adjusting extra amount of Rs. 4,42,50,000/- lakh (Rupees four crore forty two lakh and fifty thousand only) which is still available with the State Govt. of U.P. out of the total sanctioned amount of **Rs. 12,30,00,000/- (Rupees twelve crore and thirty lakh only)** for the year 2010-11 to the Govt. of Uttar Pradesh for implementing the scheme "Multi Sectoral Development Programme for minorities" for Budaun district. The non-recurring grant may be released to the Govt. of Uttar Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Centrally sponsored Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) -Other Grants, 04 - Multi sectoral Development Programme for minorities, 04.00.35 - Grant for creation of capital assets for the year 2010-11.

3. Since it is fresh release for the revised plan of balance fund, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of the financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount may also be furnished.

4. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.

5. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

\* Govt. of Uttar Pradesh has been sanctioned an amount of Rs. 1475.00 lakh for 1000 units of AWC which was approved in 12<sup>th</sup> EC meeting vide this Ministry's letter dated 06.07.09. Later on in the 35<sup>th</sup> EC meeting the state government had requested to reduce 300 numbers of AWCs from 1000 AWCs which were approved in 12<sup>th</sup> EC meeting. As a result of this, an amount of Rs. 1032.50 lakh (for 700 units of AWC) would be required instead of Rs. 1475.00 lakh (for 1000 units of AWC) which had already been released. This means that an excess amount of Rs. 442.50 lakh (=Rs. 1475.00 lakh- Rs. 1032.50 lakh) is available with the State Govt. of U.P. Therefore this extra amount of Rs. 442.50 lakh has been adjusted to incur the expenditure of the project of construction of Polytechnic with two hostels amounting to Rs. 615.00 lakh and the rest amount i.e., Rs. 172.50 lakh (= Rs. 615.00 lakh - Rs. 442.50 lakh) has been sanctioned.
