
Subject: Grant in aid to Govt. of West Bengal for IT Enabled Dedicated Cell at the State Head quarter, Directorate and 4 MCDs namely Burdwan, Murshidabad, South 24 Parganas and Dakshin Dinajpur under Multi-sectoral Development Programme for minorities to Government of West Bengal.

Sir,

I am directed to convey the sanction of the President for release of an amount of Rs. 10,80,000/- (Rupees Ten lakh eighty thousand Only) to the Govt. of West Bengal as remuneration for computer personnel for running of IT Enabled Dedicated Cell in the State Head quarter, Directorate and 4 MCDs namely Burdwan, Murshidabad, South 24 Parganas and Dakshin Dinajpur to monitor the implementation of the scheme "Multi Sectoral Development Programme for minorities" in the State of West Bengal as per the details enclosed at Annexure-I.

3. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year.
4. Utilization Certificates of 2nd phase of release of fund are enclosed.
5. Utilization of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.

- vii. Grantee will ensure that there is no duplication of work.
- viii. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
