Subject: Grant in aid of 1st installment under the Centrally Sponsored Scheme of Pradhan Mantri Jan Vikas Karyakram (PMJVK) to Central Council for Research in Unani Medicine (CCRUM) for 2022-23.

Sir,

I am directed to convey sanction of the President for release of an amount of **Rs. 4, 86, 63,000/- (Rupees Four Crore Eighty Six Lakh Sixty Three Thousand Only)** as **1st installment of Central Share (25%) to Central Council for Research in Unani Medicine (CCRUM)** during the year 2022-23 for implementation of the projects under "Pradhan Mantri Jan Vikas Karyakram" as per details of the projects at Annexure -I.

2. The expenditure is debitable to Demand No.70, Ministry of Minority Affairs Major Head- "2225" Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities -04 Welfare of Minorities (Sub Major Head), 102 Economic Development (Minor Head), -05 Pradhan Mantri Jan Vikas Karyakram, 00.35 Grant for creation of capital assets for the year 2022-23.

3 **Since it is a fresh release for the plan of PMJVK, no UC is pending.** Utilization Certificate for this grant should be submitted by the CCRUM in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 4.5.5 of the guideline of PMJVK, (i) Quarterly Progress Report, (ii) Utilization Certificate, (iii) Report regarding release of the State share and (iv) Photographs of the Assets so far created, should also be furnished.

4. The sanction is issued on the commitment given by the CCRUM that the projects mentioned in Annexure-I are located in areas having a substantial minority population (25%) and that duplication will not take place.

5. The CCRUM should ensure that a board containing information as per Template enclosed at Annexure-III is displayed at the site. After completion of projects, a permanent display would be installed.

6. This is to certify that the present sanction/expenditure is covered under MEP for the month of March, 2023 and Integrated Finance Division (IFD) has approved the expenditure during the 4th quarter of the financial year 2022-23.

- iv. The grantee will ensure that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
- v. Grantee shall not divert any part of the grant to any other activities.
- vi. Grantee shall be governed by all the terms and conditions of the grant as prescribed in the scheme/programme and in GFR.
- vii. Grantee shall endeavor to achieve the quantified and qualitative targets.
- viii. Grantee will ensure that there is no duplication of work.
- ix. Grantee to ensure that the machinery and equipment shall be procured following GFR and CVC guidelines.
