Subject: Release of Grant in aid under the Centrally Sponsored Scheme of Pradhan Mantri Jan Vikas Karyakram (PMJVK) to Government of Mizoram in the year 2024-25.

Sir,

With reference to this Ministry's Sanction of even number dated 02.07.2024 on the subject mentioned above, approval of the Competent authority is hereby conveyed for release of an amount of **Rs. 13,40,00,000/- (Rupees Thirteen Crore Forty Lakh Only)** to the Govt. of Mizoram during FY 2024-25 for implementation of ongoing projects under "Pradhan Mantri Jan Vikas Karyakram (PMJVK)" in the State of Mizoram .

2. The sanction is being issued as per para 12 of Ministry of Finance O.M. No. 1 (13)PFMS/FCD/2020 dated 23.03.2021 regarding "Procedure for release of funds under the Centrally Sponsored Schemes (CSS) and monitoring utilization of the funds released.

3. The expenditure is debitable to Demand No.70, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 64-Pradhan Mantri Jan Vikas Karyakram for minorities, 64.00.35 Grant for creation of capital assets the year 2024-25.

4. The above release of funds to State of Mizoram is subject to the following condition:

- i. The funding pattern between Centre and State is 90:10 for PMJVK.
- ii. The Expenditure from the bank account of SNA will be as per MoMA's guidelines issued vide letter No. MsDP-21/47/2020-MsDP-MoMA dated 06.12.2022. The instant release is meant for the project mentioned is the captioned subject only, till further order.
- iii. The State Government should ensure to minimize the unspent balance for all projects under the scheme, to upload the QPRs on the PMJVK Portal and to update MIS regularly. State shall ensure geo-tagging of all projects on PMJVK-Bhuvan app.
- iv. Funds should be released by the State Govt. to the implementing agencies as per the guidelines of Department of Expenditure, Ministry of Finance, Govt. of India issued from time to time and; parking of funds at any level is strictly prohibited.

- v. PMJVK being Centrally Sponsored Scheme (CSS), the State Government should strictly follow the revised procedure of funds flow issued by the DoE , M/o Finance's vide OM No. 1(13)PFMS/FCD/2020 dated 23.03.2021 and the relevant instruction issued time to time thereafter.
- vi. Utilization of the above mentioned amount by the State Government is subject to the terms and condition at **Annexure-I**.

5. The State Government/UTs shall transfer these funds along with the corresponding State Share to the bank account of State Nodal Agency for PMJVK immediately under intimation to this Ministry.

6. Utilization Certificate for this grant should be submitted by the State Govt. in the prescribed format as per the scheme guidelines and as per the timelines prescribed under General Financial Rules 2017 (G.F.R. 2017).

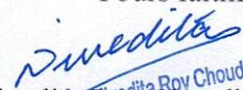
7. The funds will be utilized for the purpose for which these are sanctioned and as per the revised PMJVK scheme guidelines; otherwise funds will have to be remitted along with the interest as per provision in GFR 2017.

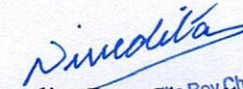

Utilization of the above mentioned amount by the grantee is subject to the following terms and conditions:

- i. Grantee will maintain a separate account of the funds released by this Ministry under this scheme/programme.
- ii. All release by the State should be made through PFMS and EAT module only.
- iii. The expenditure incurred by the grantee shall be open for inspection by the sanctioning authority/ Comptroller & Auditor General of India/Internal Audit by the Chief Controller of Accounts of the Ministry of Minority Affairs.
- iv. The grantee will ensure that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
- v. Grantee shall not divert any part of the grant to any other activities.
- vi. Grantee shall be governed by all the terms and conditions of the grant as prescribed in the scheme/programme and in GFR.
- vii. Grantee shall endeavor to achieve the quantified and qualitative targets.
- viii. Grantee will ensure that there is no duplication of work.
- ix. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
