
I am directed to convey the sanction of the President for release of an amount of **Rs. 1,28,34,000/- (Rupees One Crore Twenty Eight Lakh and Thirty Four Thousand Only)** as 1<sup>st</sup> installment to the Govt. of Karnataka for implementing the scheme "Pradhan Mantri Jan Vikas Karyakaram (erstwhile MsDP) for **Minority Concentration Areas** in **Kolar** District for the year 2018-19 as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of Karnataka through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of State share for the projects mentioned at annexure-I is released to the implementing agency along with Central share.

3. The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 49- Multi sectoral Development Programme for minorities, 49.00.35 Grant for creation of capital assets the year 2018-19.

4. Since it is a fresh release for the plan of PMJVK, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 12 of the guideline of PMJVK (i) Quarterly Progress Report, (ii) Utilization Certificate and (iii) Report regarding release of the state share in case of innovative projects will also be furnished.

5. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at annexure-II.




**Utilization of the above mentioned amount by the grantee is subject to the following terms and conditions:**

- ii. The expenditure incurred by the grantee shall be open for inspection by the sanctioning authority/ Comptroller & Auditor General of India/Internal Audit by the Chief Controller of Accounts of the Ministry of Minority Affairs.
- iii. The grantee will ensure that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
- iv. Grantee shall not divert any part of the grant to any other activities.
