Subject: Grant in aid under the Centrally Sponsored Scheme of **Pradhan Matri Jan Vikas Karyakram (erstwhile MsDP)** for Bidar, Bagalkote, Ramanagar, Hassan, Chickmanglore, Tumkur, Davanagar, Uttar Kannada, Shivmogga, Gadag, Dakshin Kannada, Belgaun, Manglore Districts to Government of Karnataka.

Sir,

I am directed to convey the sanction of the President for release of an amount of **Rs.18,61,68,000/- (Rs Eighteen Crore Sixty One Lakh Sixty Eight Thousand only)** as 1st installment for the year 2018-19 to the Govt. of Karnataka for implementing the scheme "**Pradhan Matri Jan Vikas Karyakram (PMJVK)**" for Minority Concentration Areas (MCAs) in Bidar, Bagalkote, Ramanagar, Hassan, Chickmanglore, Tumkur, Davanagar, Uttar Kannada, Shivmogga, Gadag, Dakshin Kannada, Belgaun, Manglore district as per the details enclosed at **Annexure I**. The non-recurring grant may be released to the Govt. of **Karnataka** through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of 50% of State share for the projects mentioned at annexure-I is released to the implementing agency alongwith Central share.
3. The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General- (Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 49 - Multi sectoral Development Programme for minorities, 49.00.35 Grant for creation of capital assets the year 2018-19.
4. Since it is a fresh release for the plan of PMJVK, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 12.5 of the guideline of PMJVK, (i) Quarterly Progress Report, (ii) Utilization Certificate, (iii) Report regarding release of the state share in case of innovative projects may also be furnished and (iv) Photographs of the Assets so far created (whenever called).
5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.

8. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

9. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at annexure-II.


10. This sanction issues with concurrence of IFD vide their Note. No. 14 of file no. 13/28/2019-**MsDP-MOMA** dated 20.03.2019. It is noted at S. No 167 in the Grant-in-aid Register.






Utilization of the above mentioned amount by the grantee is subject to the following terms and conditions:

- iv. Grantee shall not divert any part of the grant to any other activities.
- v. Grantee shall be governed by all the terms and conditions of the grant as prescribed in the scheme/programme and in GFR.
- vi. Grantee shall endeavor to achieve the quantified and qualitative targets.
- vii. Grantee will ensure that there is no duplication of work.
- viii. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
