

Subject: Grant in aid under the Centrally Sponsored Scheme of Pradhan Mantri Jan Vikas Karyakram (erstwhile MsDP) for Minority Concentration Areas (MCAs) to Government of Manipur for the year 2018-19 for **Churachandpur, Ukhrul, Chandel, Senapati and Tamenglong Districts of Manipur.**

Sir,

I am directed to convey the sanction of the President for release of an amount of **Rs. 6,75,00,000/- (Rupees Six Crore Seventy-Five Lakh Only)**, being 30% of the Central Share as 1st installment to the Govt. of Manipur for implementing the scheme Pradhan Mantri Jan Vikas Karyakram (erstwhile MsDP) for Minority Concentration Areas (MCAs) to Government of Manipur for the year 2018-19 for **Churachandpur, Ukhrul, Chandel, Senapati and Tamenglong Districts of Manipur** as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of Assam through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of State share for the projects mentioned at annexure-I is released to the implementing agency along with Central share.
3. The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Governments, 06- Centrally Sponsored Schemes (Sub Major Head), 101 Central Assistance/Share (Minor Head), 49 - Multi sectoral Development Programme for minorities, 49.00.35 - Grant for Creation of Capital Assets for the year 2018-19.
4. Since it is a fresh release for the plan of MsDP, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 12.5 of the guideline of Pradhan Mantri Jan Vikas Karyakra (PMJVK) (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases (whenever called) and (iii) Report regarding release of the State share in case of innovative projects should also be furnished.
5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.

7. The State Government should ensure that a board containing information as per Template enclosed at Annexure-III is displayed at the site. After completion of projects, a permanent display would be installed.
8. This is to certify that the present sanction/expenditure is covered under the MEP for the month of December, 2018 and Integrated Finance Division (IFD) has approved the expenditure during the third quarter of the financial year 2018-19.
9. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.
10. This sanction issues with concurrence of IFD Note no. 17 dated 11.12.2018 of File No. MsDP-13/124/2018-MsDP-MOMA. It is noted at S. No. 82 in the Grant-in-aid Register.


